How are T Levels structured? Who can deliver T Levels?	 T Levels consist of several components: An approved T Level Technical Qualification (TQ) that provides technical knowledge and practical skills specific to a student's chosen industry or occupation. 'On-the-job' experience during an Industry Placement of at least 315 hours (approximately 45 days). A minimum standard in maths and English if students have not already achieved them. Transferrable workplace skills. Government published the full list of providers who have been selected to deliver T Levels in the 2020 to 2021, 2021 to 2022 and 2022 to 2023 academic year. You can

How can my centre apply to be in the next phase of T Level providers?	If your centre is not already an approved T Level provider and interested in delivering T Levels, you must submit your expression of interest to the Institute. To express your interest in delivering T Levels, or to find out when the next round of applications is open, visit the gov.uk website .		
How are T Levels be funded?	You can find out more on how T Levels are funded on the dedicated T Level funding page on gov.uk.		
What T Levels are currently available and when will others be launched?	Timelines for the phased introduction of T Levels can be accessed on the gov.uk website.		
What kind of support is available for me and my colleagues to support delivery of T Levels?	Our dedicated <u>T Level provider area</u> has been designed to support providers throughout their T Level journey. It's filled with useful resources, guides and webinars to support your delivery of T Levels.		
How are T Levels developed?	The T Level panel, made up of sector experts, has been responsible for developing the outline content of the Education and Childcare, Digital Business Services, Digital Support Services, Health, Healthcare Science, and Science T Level Technical Qualifications. NCFE worked with the panel, as well as hundreds of other employers and subject matter experts, to develop the qualification specification and assessment strategy for the T Level Technical Qualifications.		
Will the T Level have UCAS points?	Yes, T Levels attract UCAS points. You can find out more on the UCAS website.		
Are we able to register students in the same way as we currently do?	Please see the <u>T Level student registration process</u> .		

Question	Answer	
In relation to destinations and progression pathways, what are they going to be for university and industry?	The progression pathway for the T Level is for students to progress into either further learning or work. You can find out more about the progression opportunities that T Levels support here.	
Does NCFE issue T Level certificates?	NCFE will not issue any certificates for T Levels or the T Level Technical Qualification; DfE will issue a certificate based on achievement.	
Will the employer mark the employer set project (ESP)?	No, the ESP is set and marked by NCFE. Employers are involved in the design and consulted on the expected standards of the students' work but will not mark the project.	
If students drop off in year 1 do they gain any qualification?	NCFE will not issue any certificates for T Levels or the T Level Technical Qualification; DfE will issue a certificate based on achievement. In relation to this query, the gov.uk website states: 'Students who do not pass all elements of their T Level will get a T Level statement of achievement which will show the elements they have completed'. What parent and student engagement material have you got?	You can find our parent and student engagement materials on our website.	
Does there need to be a qualification within the transition programme?	There is no formal requirement to put a qualification in as part of the package, however centres that currently run a transition programme have fed back they feel a qualification gives the programme more validity and improves outcomes for the student. Look out for the release soon of NCFE's new transition programme qualifications that will be available for delivery from September 2021.	
Do you have any marketing material for the T Level?	Yes, links can be found on our dedicate T Level provider area.

Will there be an opportunity for us to collaborate and share best practice with other practitioners already delivering the T Levels?	Yes, your T Level Account Executive will be able to refer you to centres who have expressed an interest in this opportunity. NCFE is also looking at other ways that centres can exchange best practice so watch this space.	
Who should I contact about T Levels at NCFE?	If you are a Wave 1 or 2 T Level provider you will have a T Level Account Executive allocated to your centre, however you can also contact our central inbox tlevelsupport@ncfe.org.uk and we will quickly put you in touch with the appropriate person.	
Can you tell me where we can access the assessment windows?	You can find our assessment dates on our dedicated T Level provider area on our website.	
What training and support do you offer?	We have a wide range of forthcoming webinars and support activity which can be found via our <u>dedicated T Level provider area</u> , or you can ask your T Level Account Executive for more detail.	
Can a student switch occupational pathways and if so, what's the last date in which they can do this?	Yes, a student can be transferred from one occupational pathway to another before completing their first attempt at the Occupational Specialism assessments. Please refer to the deadline for entry/amendments for the chosen Occupational Specialism series in our Key Dates Schedule for specific dates.	
	Once a student has attempted the Occupational Specialism assessments however, they cannot switch occupational pathway.	

Question	Answer	
Do students fail the whole course if they fail an exam and following resit. Can the ESP and		
Occupational Specialism support the grade to achieve a pass?	Each component is internally 100% compensatory in nature so, in theory, a student could fail both exams and, if they did sufficiently well in the ESP, they could still pass t Core component.	
	Similarly, there's no requirement to pass any of the Occupational Specialism assignments; assuming the overall mark is sufficient to achieve a pass, they will pass, regardless of how they've performed on individual assignments. (Please note that for EYE they must pass assignment 2, part A of the Occupational Specialism to achieve the Occupational Specialism).	
Is my EQA going to be the same?	If the T Level Technical Qualification requires moderation of the Occupational Specialism, you'll be allocated a moderator.	
	All TQ providers will require Annual Monitoring Reviews (AMR) which will be completed by a quality reviewer throughout September to November. A date for the AMR will be discussed with you at your approval review. The AMR will focus on management systems and administrative arrangements, resources, assessment and IQA but will not sample any student work. The quality reviewer and moderator will not be the same person.	
	NB: There is no moderation element for T Level Technical Qualification in Digital Business Services or Digital Support Services (Level 3), therefore you will not be allocated a moderator for these qualifications.

If the Occupational Specialism component has synoptic assignments, you must refer to the T Level Technical Qualification Specifications and Tutor Guidance on our website which provides instructions for each of the assessments.
Will a Wave 1 Education and Childcare centre that's already gone through the approval process, but had to defer to 2021	Once approved, all TQ providers will remain as an approved provider. Existing TQ providers do not need to go through the full approval process when applying for additional products. They will receive desktop approval.
have to go through the process again?	However, if the provider deferred prior to completion of the approval review, they would need to go through the approval process to be able to offer the T Level Technical Qualification.

Question	Answer
How do I prepare for a moderation review?	If you are delivering the T Level Technical Qualification in Education and Childcare: Education, you will be allocated a moderator in your second year of delivery e.g. from 1 August 2021. The moderator will moderate students who are currently in their second year of delivery. Your moderator will contact you to arrange their moderation visits. To enable them to do this, providers must send the moderator their schedule of assessment, outlining the assessments booked to take place and the assessment criteria to be covered. These visits will take place at the students' Industry Placements. You will need to gain permission from all Industry Placements before the moderator can accompany the assessor on the visit.
	To support you we've created some webinars. These webinars will be running each year and we strongly recommend that you attend these. 	T Level Technical Qualification in Education and Childcare: Education Provider Standardisation training (available from February 2021)
	If you are delivering one of our Wave 2 T Level Technical Qualifications e.g. Health, Healthcare Science, and/or Science you will be allocated a moderator in your second year of delivery. All moderation will take place remotely. Your moderator will be in touch with you to provide the information you need to prepare for moderation. Question	Answer
How do I prepare for my Annual Monitoring Review (AMR)?	Once approved your quality reviewer will book a time for your AMR to take place. This will be scheduled throughout September - November. Prior to your review, your quality reviewer will contact you to provide all the information you need to prepare for your AMR.
Will centres have to reproduce all policies and procedures and upload them to different places each time?	If you are a new provider to NCFE, you will need to provide evidence of your management systems, administrative arrangements and resources. Once approved you do not need to send these documents again. However, you will be asked to share these as part of your AMR, where your generic policies and procedures under management systems, administrative arrangements and resources must be checked as part of the AMR.
	The reason we request this every year is that we need to ensure that providers are keeping their processes under review to ensure they remain fit for purpose and are improved where necessary.
	You will not be asked to supply this as part of the moderation process as this process will only request samples of student work and associated assessment documents and evidence.

Question	Answer		
What does the 30 working day approval process looks like / involve for the centre?	Once you apply for approval you will be allocated an EQA who will conduct your approval review. Your approval review must be complete within 30 working days of your application, therefore please do not apply for approval until you are ready for this to take place within 10 working days of application.		
	Once we receive your application, an EQA will contact you within 2 working days of being allocated to arrange your approval. Your approval review must be complete within 10 working days and your EQA will work with you to arrange a suitable time to complete this. Once the EQA has all the necessary information from you and has completed their approval report, they will send this report to you within 2 working days of your review.		
	The turnaround for TQ qualification approval is set by the Institute as 30 working days. Based on this, our timescales have been set to ensure we can fully support you and meet the required timeframes your approval review.		
Does the T Level require both EQA and moderation – and will these people be different?	All TQ providers will require Annual Monitoring Reviews (AMR) which will be completed by a quality reviewer throughout September - November. A date for the AMR will be discussed with you at your approval review. The AMR will focus on management systems and administrative arrangements, resources, assessment and IQA but will not sample any student work.		
	If the T Level Technical Qualification requires moderation of the Occupational Specialism, you'll be allocated a moderator rather than an EQA who will sample your assessment decisions.		
Is there any additional guidance around industry placement?	Yes, please refer to the industry placements guidance on the gov.uk.website.		
Will there be resources available for the Occupational Specialisms?	Yes, there will be resources available for Occupational Specialism s and these will be released in due course. Please refer to QualHub for the latest information on resources.		

Question	Answer
How does moderation differ from current CACHE EQA process?	The moderation process is different to the external quality assurance process as the moderator will sample learner assessments for the moderated unit of the TQ. The moderated unit for each TQ is outlined in their Technical Qualification specifications which are available on QualHub .
	The T Level Technical Qualification in Education and Childcare requires some moderation activity at the student's Industry Placement, where the moderator will assess students alongside the provider's assessor. Final moderation will be conducted remotely. During final moderation, moderators will sample completed learner assessments.
	The T Level Technical Qualifications in Health, Healthcare Science and Science will be moderated remotely, this will take place within a specific window in the second year of the students' 2 year programme, where Moderators will sample completed learner assessments.
When will the Hodder textbook be available for the T Levels?	The textbooks for the EYE and AT Occupational Specialism s are expected to be available in May 21. The textbooks for Health, Science and Digital will be available early in 2022.
What is the window for 2021 TQ approvals?	Please refer to our key dates document which you can find on the <u>T Level provider hub.</u>

General	Will the Education and Childcare T Level provide a licence to practice upon successful completion?	Students who successfully achieve the Early Years Education and Childcare Occupational Specialism will be counted in the employment ratios for childcare.
General	When will the Education and Childcare T Level be rolled out to all providers?	By 2022 the Education and Childcare T Level will be available for delivery by all providers. By 2024 it is expected that the vast majority of providers will be delivering T Levels.
General	Will I need to move all my childcare qualifications to CACHE now you have been assigned as the T Level provider?	NCFE is the only Awarding Organisation eligible to offer the Technical Qualification component of the Education and Childcare T Level. We have a team of Account Executives who will be happy to contact you to discuss your options.

Key theme / content	Question	Answer
General	What will the T Level be covering?	The T Level is a high-quality Technical Qualification. Each T Level will provide students with 'Core' knowledge and give them a choice of routes (Occupational Specialism s). These specialisms correspond to the apprenticeship standards.
		The 'Core' content of the Education and Childcare T Level will provide students with an overview of childcare and education from birth to age 19, and cover the following areas: Child development; Supporting education; Safeguarding, health and safety and wellbeing; Behaviour; Observation and assessment; Equality and diversity; Special educational needs and disability; English as an additional language; Parents, families and carers; Working with others; Reflective practice.
		The Education and Childcare TQ will have three Occupational Specialism s in it: Early Years Education and Childcare, Assisting Teaching, and Supporting and Mentoring students in Further and Higher Education. Please note, the Supporting and Mentoring students in Further and Higher Education Occupational Specialism is currently pending approval.
General	How will placement be assessed and monitored in the Education and Childcare T Level?	You should refer to the most recent T Level Technical Qualification specification and any adaptation guidance on QualHub.

Key theme / content	Question	Answer
Registrations and bookings	When I make registrations why do I have to make my Core bookings?	Providers are required to make Core bookings at the point of registration to help prevent against missing entry deadlines and incurring unnecessary late booking fees. When selecting your chosen Core Assessment Series your students will be entered against the Core ESP and Core exams, so that you do not have to book these individually at a later date. It is easy to change your Core bookings after registration if needed. You can manage student bookings (including transfers and cancellations) via the 'Bookings' screen in the Portal. Please refer to the T Level Portal and Online Assessment User Guide for more information of transferring and cancelling bookings.
Registrations and bookings	What is the cut-off date for registrations without incurring any late registration fees?	1 November. Please refer to the key dates schedule and the fees guide on our <u>T Level provider hub</u> .
Registrations and bookings	What papers can I sit online?	When making Core assessment bookings you will have the following options: • ESP (AT/EYE) – No computer required • Core A (online or paper exam available) • Core B (online or paper exam available) Providers will need to choose the appropriate "Core set" of online or paper. The "Core set" needs to be sat either online or by paper - you can't mix and match. You can sit the Core papers only and you will have the option at the point of booking to specify if the core paper set is required online or paper.

Registrations and bookings	Can I transfer a booking once I've made it?	Yes, you can transfer bookings via the NCFE Portal.
		You can transfer Core assessment bookings to a different assessment series, to a different ESP option or between paper-based or online Core exam options.
		You can also transfer Occupational Specialism bookings to a different series or specialism (before the first assignment sitting only).

Registrations and bookings	How do I transfer a booking?	You can transfer bookings via the NCFE Portal up until the deadline for entry/amendments for your chosen assessment series as detailed in the Key Dates Schedule.

Registrations and bookings	When do I need to declare the OS per student?	This can be done at the point of registration (if a student's Occupational Specialism is already known) or via the bookings tab post-registration, in line with booking cut off dates as detailed in the key dates schedule on the qual page.
Registrations and bookings	Do I have to pay to transfer a student?	No - there are no additional admin fees to transfer a student.

Registrations and bookings	When do I need to enter my students on to the assessment?	When registering your students for a T Level Technical Qualification you must select which Core Assessment Series you would like to enter your students onto from the list of options available.
		Although you are not required to enter your students onto their chosen Occupational Specialism at the point of registration, we do actively encourage you to do so if this has already been agreed with your student(s).
		To avoid incurring late booking fees, all students must be entered before the deadline for entry/amendments for your chosen assessment series as detailed in the Key Dates Schedule.
Qualification content	The new EYFS is on early release so as part of the exam, will students be referring to the current Development Matters or will it be the new one?	Students are unlikely to sit any OS assessments until 2022, which is after the point at which Development Matters becomes statutory. QA will consider any subtle differences between what's in the spec in this session and what's in the spec after next September. Until then, both versions are relevant, and NCFE will take into account subtle differences in responses.

Other	What are the current guidelines on Industry Placement hours?	Support monitoring and control of own learning. The current guidelines are that a student must complete a minimum of 315 hours (approximately 45 days) for industry placement, although those students undertaking the Early Years Occupational Specialism will need to complete up to 750 hours in relevant work experience to sufficiently meet the Early Years Educator criteria. In recognition of the current challenges facing providers additional guidance has been added in to the Education and Childcare TQ qualification specification in the Technical Qualification summary table in Section 2 – Placement hours and Covid-19. Other	Does the T Level give a Student the required EYE status to progress on to a Teaching Degree?	The T Level does offer progression to HE with a maximum UCAS allocation of 168 UCAS points (at A*) - Please check the UCAS website for more information.
Learning Resources	Is there a textbook available from Hodder?	NCFE resource partner Hodder is developing a textbook which will cover the theory of the Core elements and Occupational Specialism s in Early Years and Assisting Teaching. We will be sharing more details on the availability of Hodder's textbook in the lead up to its launch.
		To support you ahead of the launch of the textbook, and in response to provider feedback, Hodder has created a mapping document which you can download from QualHub.
Learning Resources	When will the Hodder textbook be available for the T Levels?	The textbooks for the EYE and AT Occupational Specialisms are expected to be available in May 21. The textbooks for Health, Science and Digital will be available early in 2022.
Other	Does a learner have to pass the employer set project and exam in the first year to progress on to the second year?	No. There is no requirement for a student to pass the employer-set project and the core exams in the first year in order to progress on to the second year of delivery. Students can be booked to resit the employer-set project and/or core exams in the second year if they do not achieve their desired outcomes in the first sitting.

Other	Is there resit fee with regards to the exam?	Yes. Resit fees per student will be incurred for any additional attempts at the employer-set project, core exams or occupational specialism assessments. Please refer to the fees guide on our website.
Other	Can I deliver other NCFE and CACHE qualifications in addition to the T Level?	Yes, please review our extensive qualification offering which you can find on the NCFE QualHub or speak to your T Level account executive.

Key theme / content	Question	Answer
Other	Has the Supporting and Mentoring Students in Further and Higher Education Occupational Specialism been put on hold?	We can confirm the final Occupational Specialism for the T Level Technical Qualification in Education and Childcare has now been approved. Following engagement with stakeholders on the title of the specialism, the previous title 'Supporting and Mentoring Students in Further and Higher Education' has been changed to 'Supporting and Mentoring Students in Educational Settings'. The specialism now provides opportunities for prospective students to gain a broader spectrum of experience in the education sector. You can find materials for this specialism on the NCFE QualHub.
Assessment	I am a Nursery Manager and work part-time at college as part of the Childcare team. I do not have an assessor qualification. Can I assess?	As a Nursery Manager you will have sector relevant qualifications and current knowledge, therefore you are occupationally competent. An assessor qualification is not mandatory; however, it is expected that you will receive training and support to enable you to carry out your role with confidence and have a clear understanding of the role of the Assessor. You might also consider the assessor training events offered by NCFE. CPD records need to be maintained.

Key theme / content	Question	Answer
Assessment	I have taught early years for several years. I do not have any experience within early years settings. Can I assess the EYE assignment 2?	To assess assignment 2, you will need to be occupationally competent as you are assessing the skills requirement of the T Level Technical Qualification. The following should be considered: • Have you worked/do you have experience of a relevant setting? • Is your knowledge up to date and relevant? • Are you able to make accurate assessment decisions with you experience and knowledge? CPD records will need to be maintained. In summary, you can teach the Core and Occupational Specialism, but assessment decisions of the EYE OS Assignment 2 would depend on meeting the occupational competence in line with the points identified
		above.

General	Is NCFE developing the Health and Science T Levels?	NCFE has been awarded the contract to develop the T Level Technical Qualifications for the following 3 T Levels: Health, Healthcare Science, and Science. These Level 3 T Level Technical Qualifications will provide students with the knowledge, skills and behaviours needed to progress into skilled employment, higher level technical training or study in the Health and Science sector.
General	What are the Occupational Specialism s?	 The specialisms for the Health T Level are: Supporting Healthcare - Supporting the Adult Nursing team Supporting Healthcare - Supporting the Midwifery team Supporting Healthcare - Supporting the Mental Health team Supporting Healthcare - Supporting the care of Children and Young People Supporting Healthcare - Supporting the Therapy teams. The specialism for the Healthcare T Level is: Assisting with Healthcare Science. The specialisms for the Science T Level are: Technical: Laboratory Sciences Technical: Food Sciences Technical: Metrology Sciences.
General	When will these Health and Science T Levels be available for delivery?	From September 2021 all Health and Science T Levels will be rolled out for delivery for Wave 1 and Wave 2 providers.

Qualification content	What does the route Core content entail?	The Core content for the 3 T Levels will cover the following areas: Working within the Health and Science sector, Health, Safety and Environmental regulations in the Health and Science sector, Managing information and data within the Health and Science sector, Good Scientific and Clinical Practice, Core Science concepts. The breadth of content will ensure students can apply their skills for different purposes and in different roles.
Qualification content	Where are the Technical Qualification specifications for these T Levels?	The Technical Qualification Specifications for these T Levels can be accessed via the links below: • T Level Technical Qualification in Health (Level 3) • T Level Technical Qualification in Healthcare Science (Level 3) • T Level Technical Qualification in Science (Level 3)
Learning Resources	Will there be any specific equipment requirements to deliver the TQ?	Yes, and the list is detailed in the qualification specification. There is funding available to support centres via ESFA (Special Equipment Fund).
Other	What would be the potential student destinations for Assisting with Health Care?	The Assisting with Health Care specialism can support progression into a range of clinical fields such as: Clinical Screening Phlebotomist Audiology dept Pathology labs Cardiology dept Respiratory dept.

Key theme / content	Question	Answer
Assessment	To deliver one of the Health Occupational Specialism s, does a member of the delivery team need to be a registered practitioner?	No, staff are not required to be registered practitioners, however, they must be able to demonstrate that they have (or are working towards) the relevant occupational knowledge and/or occupational competence in the relevant Occupational Specialism area, at the same level or higher as the qualification being delivered. This may be gained through experience and/or qualifications or CPD.
Assessment	Can someone who has no recent occupational experience, CPD or recent qualifications within the occupational area, but has health teaching experience, deliver on the Occupational Specialism s?	No as they will not be competent to deliver the Occupational Specialism content without experience, a record of recent qualifications or completion of a formal occupational qualification.
Assessment	Can someone with a good occupational background but minimum teaching experience and no teaching/assessing qualification deliver on the T level qualification? This may be gained through experience/a recognised teaching/assessor qualification or relevant CPD within teaching/assessing.

Yes, however they must be able to demonstrate that they have (or are working towards) the relevant occupational knowledge and/or occupational competence in the area they are teaching. For example, a Health teacher may not be confident and competent teaching element B1: Core Science concepts.

No, as they must be confident and competent at assessing within the occupational area and must be able to demonstrate they are competent at making reliable and valid assessment decisions. Without experience, qualification or recent CPD in assessing, they cannot demonstrate this.
Assessment	Can someone with no formal assessor qualification but good recent occupational experience and who has undertaken recent CPD within assessing be involved with the occupational assessments?	Yes, as they have demonstrated competence at assessing within the occupational area through their experience and demonstrated they are competent at making reliable and valid assessment decisions through the recent assessing CPD they have completed.
Assessment	Can someone teach across different Occupational Specialism s, for example Supporting Adult Nursing and Supporting the Mental Health Team?	Yes, if they are able to demonstrate that they have (or are working towards) the relevant occupational knowledge and/or occupational competence in the areas they are teaching. This may be gained through experience/a recognised formal occupational qualification or relevant CPD within the occupational area.
