# About this qualification

This qualification focuses on direct chair-side work and support during a range of dental treatments. It encompasses the underpinning ethics, professionalism, teamwork and communication required to work as a Dental Nurse.

The qualification covers the current General Dental Council (GDC) learning outcomes and Skills for Health National Occupational Standards and on completion it will enable learners to register with the GDC\*.

This qualification has been awarded UCAS points from May 2020 onwards. Please visit the UCAS website for more information about tariff points.

## Entry requirements

Learners must be at least 16 years old. We do not set any other entry requirements but Centres may have their own guidelines.

## Experience in the workplace

Learners will need to be working or on practical placement to be able to show competence in knowledge, understanding and skills. It is recommended that learners spend a minimum of 16 hours per week in a Real Work Environment.

If learners are already working as a Dental Nurse this qualification could be undertaken to consolidate and extend their knowledge, understanding and skills. It will also confer their competence in their role as a Dental Nurse.

If learners are on practical placement, this qualification will provide them with the necessary knowledge, understanding and skills which will support them to gain employment as a Dental Nurse.

## Qualification structure

Learners must achieve 49 credits from the 17 mandatory units.

All knowledge and skills learning outcomes and assessment criteria must be met for each unit. In addition, learners must achieve a pass, merit or distinction in the two external assessment tests (part 1 and part 2) covering the underpinning knowledge across units DN 12-16.

There is no compensation between units, or between observations and unit tasks within a unit.

## Assessment

Units DN 1 - DN 11 and unit UF AE are internally assessed, and units DN 12 - DN 16 are both internally and externally assessed.

A recommended range of assessment methods has been identified for the units in this qualification. This gives the opportunity for different learning styles and individual needs of learners to be taken into account:

- \*Direct observation (by a qualified Assessor who is a GDC registrant and meets our assessment principles)
- Expert witness evidence
- Professional discussion
- \*Reflective accounts (Learner log or reflective diary)
- Written and pictorial information
- Optional task set by us for knowledge learning outcomes/underpinning knowledge for skills learning outcomes
- Oral questions and answers.

## Progression

- orthodontic therapist
- laboratory technician
- dentist
- senior nurse
- practice manager
- lecturer
- teacher and assessor of student dental nurses.
