About these qualifications

The Level 3 Award in Childcare and Education prepares learners to progress to the Level 3 Certificate in Childcare and Education and then on to the Level 3 Diploma in Childcare and Education (Early Years Educator), which enables them to gain the knowledge and experience which will allow them to work with children from birth to 5 years.

The Level 3 Diploma in Childcare and Education (Early Years Educator) enables learners to enter the workforce as Early Years Educators or access Higher Education.

These qualifications have been awarded UCAS Tariff points. For a full breakdown of points please refer to the UCAS website or each qualification page on Qual Hub.

Qualification structure

Rules of combination for the Award:

In order to achieve the Level 3 Award in Childcare and Education learners must complete 2 mandatory units, Guided Learning: 180 (hours) including all the criteria learners must know about within the delivery requirements.

Total Qualification Time: 227 (hours)

Rules of combination for the Certificate:

In order to achieve the Level 3 Certificate in Childcare and Education learners must complete 8 mandatory units Guided Learning: 540 (hours) including all the criteria learners must know about within the delivery requirements.



Total Qualification Time: 699 (hours)

Rules of combination for the Diploma:

In order to achieve the Level 3 Diploma in Childcare and Education (Early Years Educator) learners must complete 15 mandatory units Guided Learning: 1080 (hours) including all the criteria learners must know about within the delivery requirements.

Assessment

All units will be internally assessed using a range of methods. All units are graded A*-D. Learners taking the Certificate must also complete an Effective Practice Study Task (externally set, externally marked).

Learners taking the Diploma must also complete an Effective Practice Study Task and one Extended Assessment Task (externally set, externally marked).

Within each qualification there is a maximum of one further opportunity after the first submission for learners to submit the External Assessment in order to achieve a pass grade or to improve a grade.

Placement requirements

The Award has no requirement for placement.

We suggest that the following placement allocation is applied to the Certificate and Diploma. We acknowledge that some learners may need to spend longer in placement with specific age ranges and for this reason there is a degree of flexibility. All assessment criteria must be achieved and each age range must be experienced but significant placement experience across the age ranges must be undertaken in order to achieve the assessment criteria.

Learners who work within a setting which provides care and education for children across these age ranges, and are able to gain the necessary hours of experience, need not seek placement outside of their setting.

When working in partnership with employers, decisions relating to learners' competence must be made by qualified, occupationally competent Assessors.

During placement, learners will need support from a professional within the real work environment.

Progression opportunities

The Level 3 Diploma in Childcare and Education (Early Years Educator) enables learners to access Higher Education.

Alternatively, learners can progress into various job roles in the statutory, voluntary or private sectors such as:

- Early Years Educator (Diploma only)
- practitioner in day nurseries
- practitioner in nursery schools
- practitioner in reception classes in primary schools
- · pre-school worker
- home based childcarer
- nanny
