Aims and objectives

This qualification aims to:

 focus on the study of the basic principles of health and safety, including hazards and risks within the workplace

The objectives of this qualification are to help learners to:

- understand the importance of health and safety procedures
- raise awareness of the potential hazards and risks in the workplace
- understand the implications of poor health and safety
- know key rights and responsibilities relating to health and safety

Support handbook

Guidance for entry and registration

Resource requirements

There are no mandatory resource requirements for this qualification, but centres must ensure learners have access to suitable resources to enable them to cover all the appropriate LOs.

Work/industry placement experience

This is a knowledge-only qualification. Work/industry placement experience is not required.

How the qualification is assessed

Assessment is the process of measuring a learner's skill, knowledge and understanding against the standards set in a qualification.

This qualification is internally assessed and externally quality assured.

The assessment consists of one component:

• an internally assessed portfolio of evidence which is assessed by centre staff and externally quality assured by NCFE (internal quality assurance (IQA) must still be completed by the centre as usual)

Learners must be successful in this component to gain the Level 1 Award in Health and Safety Awareness.

All the evidence generated by the learner will be assessed against the standards expected of a level 1 learner for each LO.

Unless otherwise stated in this specification, all learners taking this qualification must be assessed in English and all assessment evidence presented for external quality assurance must be in English.

Internal assessment

Each learner must create a portfolio of evidence generated from appropriate assessment tasks, which demonstrates achievement of all the LOs associated with the unit. On completion of the unit, learners must declare that the work produced is their own and the assessor must countersign this. Examples of suitable evidence for the portfolio are provided in section 2.

If a centre needs to create their own internal assessment tasks, there are 4 essential elements in the production of successful centre-based assessment tasks, these are:

- ensuring the assessment tasks are meaningful with clear, assessable outcomes
- appropriate coverage of the content, LOs, or assessment criteria
- having a valid and engaging context or scenario
- including sufficient opportunities for stretch and challenge for higher attainers

- 1. Understand the importance of health and safety in the workplace
- **1.1 Health and safety in the workplace** to include the Health and Safety at Work, etc. Act 1974 is the main law that allows other laws to be made and covers various things. These other laws contain rules that people at work need to follow and are generally called regulations.

Learners must state why health and safety in the workplace is important for:

- employees and others in the workplace
- employers

- 2. Understand the need for risk assessment
- **2.2 Risk assessment** must cover what needs to be done when carrying out a risk assessment. This could include the 5 steps to risk assessment.

2.3 Accidents could be caused by:

- trips and falls
- lifting and handling
- use of machines
- use of chemicals
- transport injuries

2.3 III health could be caused by:

- noise
- asbestos
- vibration
- skin-disease
- stress
- 3. Be aware of the requirements for health and safety his/her place of work or learning

3.2 Reporting:

The Reporting of Injuries, Diseases and Dangerous Occurrence Regulations 2013 (RIDDOR). This regulation places a legal responsibility on employers to report serious workplace accidents, occupational diseases and specified dangerous occurrences (called near misses).

Learners should explain that the easiest and quickest way to send a report is by completing the appropriate online form on the Health and Safety Executive (HSE) website: www.hse.gov.uk. A telephone service can be used to report fatal and major injuries.

Learners must describe who they would report injuries, ill health and unsafe conditions and accidents to, including the person's work title and location. They must also describe what information they would expect to find in an accident book/form.

3.3 Provision for first aid must include:

- how many first aiders have been appointed
- · where the first aiders are located
- where the first aid room is situated
- where the first aid boxes are located
- any other first aid equipment

Range

3.4 Personal protective equipment (PPE):

PPE as defined in the Personal Protective Equipment at Work Regulations 1992 (as amended).

Delivery and assessment guidance

This unit could be assessed through a workbook, learner reports, oral or written questioning and information leaflets.

Group discussions used as evidence should be supported by peer or assessor witness testimonies detailing the key learning points raised and the contribution of each learner.

1.1 Learners must state 2 reasons why health and safety in the workplace is important for employees and 4 reasons for employers.

Learners could provide examples of health and safety regulation. Depending on their place of work or learning the regulation chosen may relate to, for example, machinery, equipment (including computers) or precautions for fire or first aid facilities.

- **1.2** Learners must provide a description and include 5 employer responsibilities, 3 employee responsibilities and one responsibility of a self-employed individual.
- **1.4** Learners must identify at least 3 sources of health and safety information within their own place of work or learning.

Sources of information will vary depending on the learners' place of work or study.

1.5 Learners must identify 3 other sources of health and safety information.

Sources of other information will vary depending on the learners' place of work or study.

- **2.3** Learners must give 3 examples of work-related accidents and 3 examples of work-related ill health.
- **3.1** Learners must focus their answers on their own place of work or learning and provide 3 examples of health and safety information that should be provided for an employee or learner.
- **3.2** Learners responses will depend upon the arrangements within their place of work or learning.
- **3.4** Learners can choose the occupational sector in which they work or perhaps in which they are interested. They should name the occupational sector, describe the appropriate PPE and describe the hazards which the PPE protects against.

Assessment strategies and principles relevant to this qualification

The key requirements of the assessment strategies or principles that relate to units in this qualification are summarised below.
