

### **Qualification Facts and FAQs**

In order to assist learners and Centres with choosing between two of our Level 2 Certificates found within our early years suite, we have highlighted the main differences of each qualification below.

#### **Qualification Titles**

NCFE CACHE Level 2 Technical Certificate in Working with Children in Early Years and Primary Settings (603/3292/X)

NCFE CACHE Level 2 Certificate in an Introduction to Early Years Education and Care (601/2536/6)

### Are any of these qualifications replacing the other?

No, these qualifications provide two different pathways for the learner.

The Level 2 Certificate in an Introduction to Early Years Education and Care is ideal for learners looking to work with children between birth and five years of age, and gain knowledge of working with children up to seven years.

The Level 2 Technical Certificate in Working with Children in Early Years and Primary Settings has been designed to meet the Department for Education's requirements for a Technical Certificate and is included in the 2020 16-19 Performance Tables. It will support post-16 learners who wish to develop their knowledge, understanding and skills when caring for and supporting the learning and development of children aged 0–11 years 11 months.

The Level 2 Technical Certificate in Working with Children in Early Years and Primary Settings is also suitable for learners wishing to take it as part of a full study programme alongside GCSE English and mathematics and for those learners who wish to progress to Level 3 qualifications or to the workforce.

Both qualifications support progression to any of the following sectors:

- early years educator
- supporting teaching and learning
- children and young people qualifications.

Both qualifications require learners to experience time in a real work environment. The Level 2 Technical Certificate in Working with Children in Early Years and Primary Settings requires learners to spend some time with children in their early years as well as some time in primary school settings. Unlike the Level 2 Certificate in an Introduction to Early Years Education and Care, placement requirements do not make up each unit. Instead, a professional skills record monitors development and offers tasks for completion.

In order to satisfy DfE requirements around external and synoptic assessment the Level 2 Technical Certificate in working with children in Early Years and Primary settings will also have an externally assessed short answer examination.

However the Level 2 Technical Certificate in Working with Children in Early Years and Primary Settings includes significant transferable knowledge for learners also interested in progressing to the health and social care sector.
